	Currently a problem exists with the new money market redemption gate posting logic for transactions posted for either multiple plans (global transaction processing) or transactions posted through STP, where redemptions would cause gate violations. In either of these scenarios, the posting logic is not applying the gate logic to participants whose redemptions would violate a redemption gate.
